Web Site Privacy Statement

Grizella Corporation (Grizella) believes that privacy is important to the success and use of the Internet. This statement sets forth Grizella's Privacy Statement for all web sites and web-based applications provided by Grizella and describes the practices that Grizella will follow with respect to the privacy of users of such sites and applications. This Privacy Statement does not apply to Grizella's offline information collection activities. From time to time, we may change this Privacy Statement. For example, as we update and improve our service, new features may require modifications to the Privacy Statement. Accordingly, please check back periodically.

Personally Identifiable Information: "Personally identifiable information" is information about you, such as name, address, e-mail address, user ID, credit card number, and so on.

Information Collection, Use and Distribution: We do not collect information from which you can be personally identified -- including your e-mail address -- unless we first ask you for it. On some of our sites, we may request that you voluntarily supply us with information, including your e-mail address, street address, telephone number or other information so that we may enhance your site visit or follow up with you after your visit. Whether you provide any information is entirely up to you.

If you have voluntarily provided information, you consented to the collection and use of your personally identifiable information as described in this Privacy Statement. In some circumstances, Grizella may share information you voluntarily provide us with trustworthy business partners. We do not sell or rent personal information collected through this site to anyone. Also, Grizella may provide aggregate statistics about visitors to our sites, such as volume, traffic patterns, and related site information to reputable third-party vendors, but these statistics will include no personally identifiable information. Grizella may also disclose information in special cases when we have a good faith belief that such action is necessary to: (a) conform to legal requirements or comply with legal process; (b) protect and defend our rights or property; (c) enforce the Web site Terms and Conditions of Use; or (d) act to protect the interests of our users or others.

If, in connection with your use of a particular application or service, we ask to use your data in a way not described in this Privacy Statement and you do not wish to permit that use, you can choose not to use the particular application or service.

If you have voluntarily provided personally identifiable information, we may, from time to time, send you mail or e-mail regarding products and services. If you do not want to receive such offers and mailings, you can easily indicate that by checking the appropriate box on the submission form.

Updating Your Information: You may view and edit your personally identifiable information at any time by logging into your application or service account.

Information Security: We exercise great care to protect your personally identifiable information. This includes, among other things, using industry standard techniques such as firewalls, encryption, intrusion detection and site monitoring. Unfortunately, no data transmission over the Internet can be guaranteed to be 100% secure. As a result, while we strive to protect your personally identifiable information, we cannot ensure or warrant the security of any information you transmit to us or receive from us or through one of our applications. This is especially true for information you transmit via e-mail. We have no way of protecting that information until it reaches us. Once we receive your transmission, we use what we believe are commercially reasonable effort to ensure its security on our servers.

Internally, we will restrict access to your personally identifiable information to employees or contractors who need access to the information in order to do their jobs. These employees and contractors are required to adhere to our privacy policies.

We will review our security arrangements from time to time as we deem appropriate.

Protecting Your Information: If you are using a Grizella web site or application for which you registered and chose a password, we recommend that you do not divulge your password to anyone. We will never ask

you for your password in an unsolicited phone call or in an unsolicited e-mail. Also remember to sign out of the application or site and close your browser window when you have finished your work. This is to ensure that others cannot access your personal information and correspondence if others have access to your computer.

Cookies: Some Grizella applications and sites, like many other commercial applications and web sites, may utilize a standard technology called "cookies" to collect information about how our site is used. Cookies are designed to help a web site operator determine that a particular user has visited the site previously and thus save and remember any preferences that may have been set while the user was browsing the site. Cookies are small strings of text that web sites can send to your browser. Cookies cannot retrieve any other data from your hard drive or obtain your e-mail address. If you are simply browsing a Grizella informational site, a cookie may be used to identify your browser as one that has visited the site before.

We may also make use of memory-based cookies in support of authenticating the user of certain Grizella web applications. Similarly, if you are a registered user of a site providing service to Grizella clients (and have a user ID and password), such sites may use cookies to provide personalized information based on preferences you have indicated while using that site. Although you have the ability to modify your browser to either accept all cookies, notify you when a cookie is sent, or reject all cookies, it may not be possible to utilize, or utilize fully, such sites or services which require registration if you reject cookies.

Terms and Conditions: Please also visit our Terms and Conditions section, which sets forth permitted application and web site use, disclaimers, and limitations of liability governing our applications and web sites.

Privacy Statement Changes: As noted above, we may change our privacy policies from time to time and we may also modify this Privacy Statement. If we plan to use your personally identifiable information in a manner different from that stated at the time of collection we will notify you via the e-mail address that you have provided to us or by other means that are reasonable under the circumstances. You will have a choice as to whether or not we use your information in this different manner. In addition, if we make other material changes in our online privacy practices that do not affect user information already stored in our database, we will post a prominent notice for a period of at least 60 days on our Web Site (which may be within this Privacy Statement) notifying users of the change. In some cases, when we post such a notice we may also e-mail users who have opted to receive communications from us, notifying them of the changes in our privacy practices.

Other Sites: Grizella sites may contain links to other sites, including those of our business partners. While we seek to link only to sites that share our high standards and respect for privacy, we are not responsible for the privacy practices employed by, or the content contained on or accessible from, such other sites.
